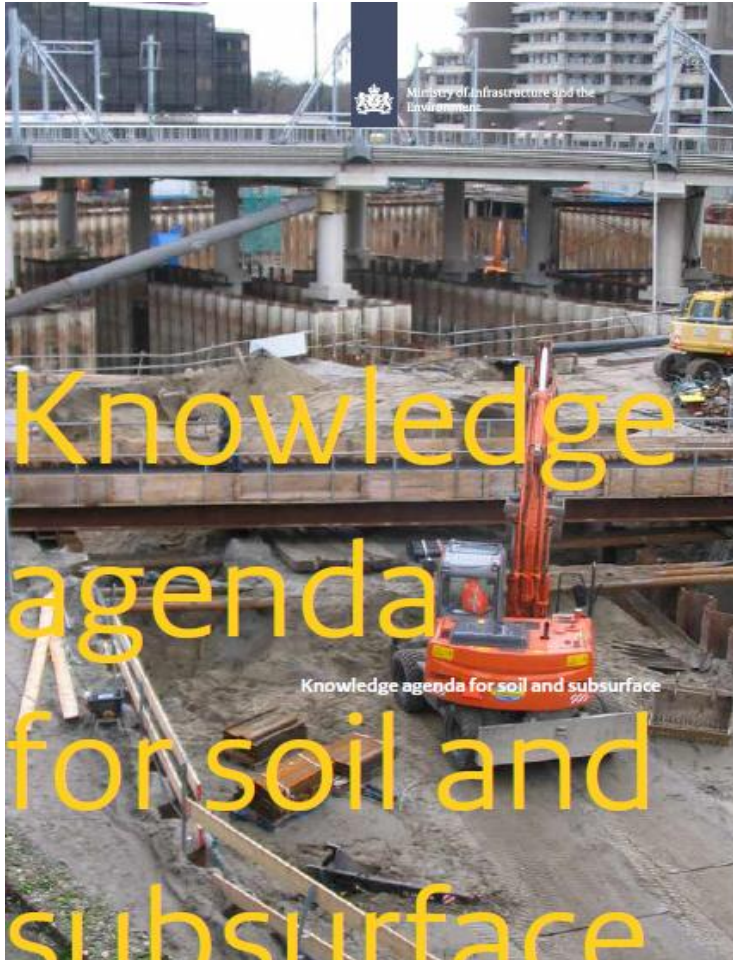

- ◆ Why are we working on soil remediation, clean up and reuse?

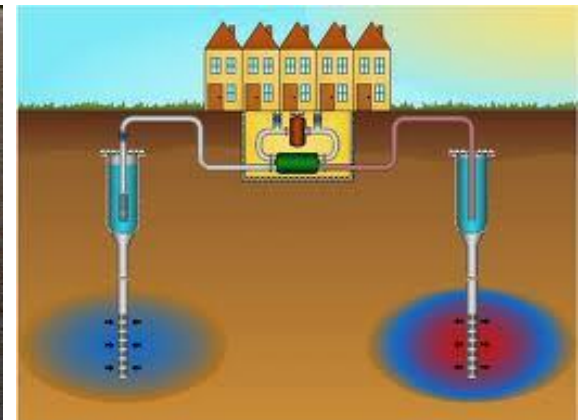


- ◆ Barcelona 2013: inventory of current and future (national) research priorities for soil and groundwater :
  1. Water and Food
  2. Urban land
  3. Green industry
  4. Energy and other resources
- ◆ Is the agenda changing from soil protection to soil management and sustainable use by current societal challenges?



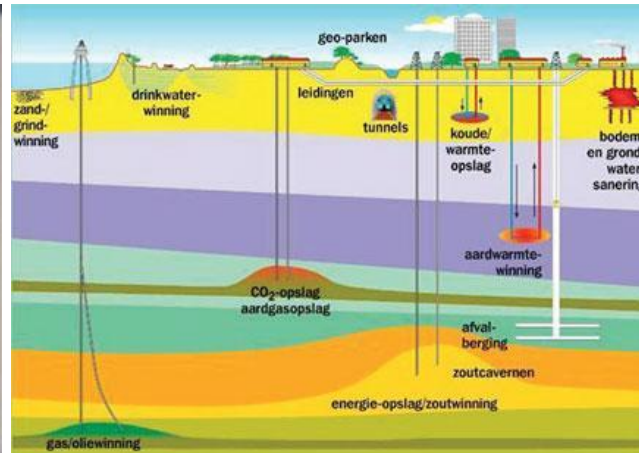
# Changing policy agenda in the Netherlands

- ◆ Societal challenges: climate change, urbanisation in a Delta environment, food safety and security, energy transition, safe and sufficient drinking water, pressure on natural resources, wish for greening the economy and circular economy
- ◆ Enormous social costs because of unconscious use of the SSW system
- ◆ Benefits left unused by ignorance of potential of services of the SSW system



# The society in charge

- ◆ Grown interest of social partners, businesses and industries
- ◆ A social initiative on conscious use and management has put the importance of the SSW system on the political agenda
- ◆ A covenant with social partners, a shared knowledge agenda
- ◆ The development of a spatial plan for sustainable use of soil and subsurface

- ◆ Practical: multi discipline pilots and demo's with mixed consortia: science-policy-industries-users

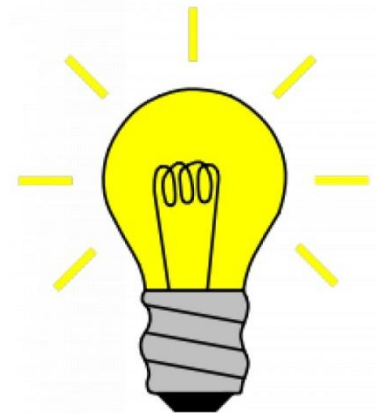
